**3. FOUNDER TRUSTEES:**

- a) There shall be a board of Trustees with both authors of the trust as founder trustee and both of them shall be for life founder trustee. The founder Trustee Mr. Mukesh Kumar Singh donates Rs. 10,000/- (Ten Thousand only) vide DD No. 001447 dated 05.10.2013, Bank of India, Rbj and Mr. Sandeep Chaurasia donates Rs. 5000/- (Five thousand) only) vide Cheque N. 505648 dated 05.10.2013, ICICI Bank, Rbj. Further, the first Board of Trustees may co-opt another eligible person as members of the Board of Trustees with their powers and rights defined along with their office tenure.
- b) The Board of Trustees shall consist of not less than two persons and not more than fourteen persons for time being. The above limits may be changed by decision of all the Board of Trustees in a meeting specially convened.
- c) The Trustees may retire after giving three calendar months pre notice in writing of his intention to do so to each other Trustees for the time being and upon the determination of such period the Trustees giving such noticed shall *Ipsa Facto* cease to be the Trustees of the Trust.
- d) Office of a Trustee shall be honorary, but he shall be entitled to be paid the actual expenses and charges incurred by him in attending to the activities and in carrying out of the objects of the Trust.

6. **THE ANCILLIARY TO THE OBJECT:** The incidental and ancillary to the object of the Trust shall be as follows:

- a) Raise the funds to support the Aim & Object of the Trust from within India and abroad.
- b) To solicit, receive, hold the funds to promote the objects stated above and to hold funds and investments in Trust for the said objects.
- c) To open and operate accounts of any description with any bank or banks of the TRUST.
- d) To appeal for the raising the funds, subscriptions, grants and loans as the TRUSTEE may think fit.
- e) To take on lease or acquired property by purchases, gift, donation or otherwise to promote the objects of the TRUST.
- f) To purchase, take on lease, leave, license and hires or otherwise acquire and to hold, manage administer and otherwise deal with any movable and immovable properties, rights and privileges as the TRUST Board may deem necessary, expedient desirable for the promotion of the objects of the TRUST.
- g) To sell, alienate, lease, give out on lease or license, mortgage, charge, pledge, hypothecate, transfer, surrender, dispose of and/or otherwise deal with all or any of the properties, funds and assets of the TRUST without profit motive and only in the rarest occasions as the board may feel deem necessary, expedient or desirable for the promotion of any of the objects of the TRUST.
- h) To appoint agents or representatives or other workers on such conditions as may be thought fit and agreed by the Board of Trustees.
- i) To enter into any contract of promoting any of the objects of the TRUST without profit motive.
- j) The income and contributions that may be received shall be spent towards the promotion of the objects of the TRUST and any incidental work connected and no portion of it shall be utilized for payment to TRUSTEES by way of profit, interest, dividend etc.

7. **BOARD OF MANAGEMNT:** To execute the function of the Trust there shall be a Board of Management. The following trustees and person are nominated by the authors of the Trust as a member of board of management with their designation as under:

8. **THE POWER AND AUTHORITY OF THE MANAGEMENT AND BOARD OF TRUSTEE:** The power & authority of the management & board of trustee shall be as under:

- a) The day-to-day affairs of the TRUST shall be carried on jointly and in coordination by both founder trustee namely **Mr. Mukesh Kumar Singh and Sandeep Chaurasia**
- b) **Mr. Mukesh Kumar Singh and Sandeep Chaurasia** shall be the Managing Trustee and they shall be entailed to continue as such during his lifetime or survivor. The said Managing Trustees shall have right to nominate or appoint, the next Managing Trustee during his life time or by will. Should a vacancy arise in the office of the Managing Trustee either by failure to nominate a successor or by non-acceptance of the office by the nominee or otherwise by efflux of time, the remaining trustees shall elect Managing Trustee on such terms for such period as may be specified by a resolution of the Board of Trustees.
- c) The other trustees will act as Trustee from this date.
- d) The Trustees other than Managing Trustee shall be liable to retire as may be specified in the letter of invitation given to them.
- e) In the case of death, resignation etc. of the Trustees, the Managing Trustee has the power to appoint any person to his place as Trustee.
- f) The number of Trustee including the Managing Trustee shall not exceed 14 at any time.
- g) The Managing Trustees have the power to invite any other person for the board meeting as an observer at any issue.
- h) Subject to the provisions herein, the board of trustees shall be entitled to exercise all such powers and do all such acts and things as are necessary to carry out the above mentioned objects.
- i) The Board of Trustees shall meet at least once a year for approving the Statement of accounts and to approve other agenda or issue.

- j) The Board of Trustees shall act as a man of ordinary precedence with care and interest in discharging duties diligently and faithfully for the greatest advantage to achieve the objectives of the TRUST.
- k) They should not act in deterioration to the name and assets of the TRUST. If any loss occurs because of the dishonest and carelessness of the Trustees then he/she should be personally liable for such loss or losses.
- l) If a Trustee is proved by appropriate evidence as dishonest and or his/her activities are proved to be against the interest of the TRUST then the remaining Trustees with the consent of the Managing Trustee may serve notice of termination on her/her after calling for his/her explanation.
- m) The Board shall be entitled to make and prescribe from time to time and rules and bye-laws, to secure the objects of the TRUST.

09. **BANK ACCOUNTS:** The bank account of the trust shall be opened with joint signature of both the Managing Trustees **Mr. Mukesh Kumar Singh and Sandeep Chaurasia** and it shall operate bank accounts of the Trust.

It shall be lawful for the Board of Trustees to frame Rules and Regulations for the conduct and management of the TRUST.

10. **BOOKS OF ACCOUNTS:**

The Board of Trustees shall cause to maintain true and correct accounts of the Trust Funds and such accounts shall be closed once in a year on 31<sup>st</sup> March. Within three months of the close of the accounting years, a statement of receipts and payments, income and expenditure account and balance sheet shall be drawn up and such accounts and statements shall got audited by a Chartered Accountant and it shall be placed before the meeting of the Trustees within a period of six months.

11. **INVESTMENTS:**

The funds of the Trust shall be invested in acquiring both movable and immovable properties to increase the income of the Trust and the excess funds shall be invested in the modes specified under section 11(5) subject to the provisions of Section 13(1) of the Income Tax Act, 1961 or any other law in this respect and rules framed under this Act or law and is in force for time being in the Territory of India.

12. **NATURE OF TRUST:**

The benefit of the activities of the Trust is Charitable and opens to all, irrespective of their caste, creed, gender, religion or region.
